1. Products will be invoiced at prices as stated on the written sales contract.
2. Any defective or out of condition stock will only be credited or replaced if we are informed within 72 hours of their delivery. All such goods must be returned to us or made available for inspection.
3. Title to the goods shall only pass to the buyer after full payment has been made to, and accepted by The Dairy Kompany Ltd.
4. The seller reserves the right to repossess any goods in respect of which payment is overdue and thereafter to re-sell the same and for this purpose the buyer hereby grants an irrevocable right and licence to the sellers' servant and agents to enter upon all or any of its premises with or without vehicles during normal business hours. This right shall continue to subsist notwithstanding the termination or cancellation of the order for any reason and is without prejudice to any accrued rights of the seller thereunder or otherwise.
5. Until full payment had been made for the goods, The Dairy Kompany Ltd retains the right to repossess goods without notice, in addition to those rights provided by law.
6. The Dairy Kompany Ltd reserves the right to charge interest on overdue accounts at the rate of 7% over Lloyds Bank base rate. In addition, charges will be levied in respect of unpaid cheques.
7. Payment of monthly accounts are due 28 days from date of invoice.
8. All contractual disputes are governed by the laws of England and Wales.
